## **Presidents Report 2012-2013**

Firstly, thank you the all the other committee members, Barry Emms, Peter Kingsbury, Bob Jelley, Peter McCrea, Vaughan Lucking and Rudolph Meltzer who have all been working behind the scenes for what has been a busy year with introducing more structure to an evolving club.

With the number of karters we now have on the track combined with the limitations that the museum extensions has caused, the committee is constantly working on ideas to improve safety and enhance members sailing enjoyment.

A few of these changes have been:

- the introduction of the Officer of Day,
- more thorough briefings including education of the rules,
- the splitting of classes for races if numbers are too high so as to avoid congestion on the taxiway, and
- setting up lanes at the two corners to split opposing traffic.

This year we tried a change to the format for club champs with spreading it over a period of time. Unfortunately, with so many windless days it did ended up dragging out for too long. However, we did finally get through it with the some great racing over the series. Congratulations to the winners and place getters.

**A number of significant events occurred over this year:**

### **TOTS Visit in May (19 and 20)**

We had a visit from a good sized contingent from Top of the South Blokart Club. The weekend provided good sailing Saturday and giving the visitors;

- # The chance to get use to sailing on tarmac,
- # Practicing starts and
- # Gaining a better understanding of the rules.

Although the winds let the visit down on the Sunday it still proved to be a successful weekend. Especially for us as a club, as we discovered a new start line position for northerly, westerly and southerly winds by utilising the taxiway.

### **North Island Open June (2 and 3)**

Queen's Birthday Weekend saw the club have its largest contingent of members to date participate in an event away from the home island. This being the North Island Open held at Ohakea Air Force Base.

12 in total made their way north and produced outstanding results in a field of experienced sailors holding titles from many national and international events. Three of our club members produced podium finishes with others very close.

### **NZ Open October (8 to 12)**

Five club members made the trek to Ardmore in Auckland, the home of the Auckland Blokart Club. Over the five days of sailing all conditions were thrown at participants. Although no podium results

were gained, all CBC members held themselves proud in a strong field at a fantastic venue, all be it hard on tyres.

### **South Island Open November (8 and 9)**

This was the first major event hosted by the Top of The South Blokart club and proved to be a great success. Fifty one sailors from throughout New Zealand entered, including thirteen from our club. Two of our members finished in the top three of their class.

### **Canterbury A&P Show November**

It was decided set up a display at the Canterbury A&P Show. This initiative was financially supported by Urban Wheels, Blokart International and NZBAI. With the assistance of many club members at the show followed with the open days the event proved to be a resounding success by attracting several new members to the sport and capturing Blokart owners who did not know about the club.

Also thank you to Blokart International Limited for sending Ash Rawson and his wife Kerryn from Papamoa to help with the weekend. Along with the personnel assistance they also generously loaned of a good number of sails for the ensuing open days.

### **TOTS Visit/Challenge January (21 & 22)**

The inaugural challenge between TOTS and us was held over the two days. A total of 30 races were completed which was an impressive feat and can be attributed to the race control by the crippled Steve Hall and Irene Jolley along with other volunteers you kept the field moving. Wind conditions varied from light to strong giving a broad range of sailing conditions to suit all. Canterbury won the trophy this time round and we are looking forward to the trip north later this year.

### **Masters Games February (2 & 3)**

This saw 9 members make the trek north to Ohakea Air Force Base for the opportunity to sail again at what is a considered the best blokarting venue in New Zealand. Another great weekend of sailing and socialising with 5 of our contingent coming away with medals.

I am of the opinion that the contributing factors to our increasing number of placing's at national events can be put down to two things.

- Our willingness as a club to help each other improve their skills through tech nights and just sharing ideas. This coupled
- with the restricted taxiway, and our predominant easterly winds, we now have to get the best out of our karts through more tacking up wind and gybing downwind.

### **Future Projects**

Prior to last year's AGM a funding application towards the purchase of a ride on lawnmower was made to the New Zealand Community trust. Regretfully, it was declined. But in hind sight it may have been for the best as we found that even with the mowed tracks done to date, we required extremely strong winds to be able to utilise theses mown routes.

However an application to the Canterbury Community Trust for funding towards additional sealed track was successful and the great news is that they have donated \$10,000 towards this project. We have 12 months From April 13 to complete the project or the funds are to be returned. The committee is currently investigating options to achieve the best result from this donation.

Our membership has stayed steady at 63

We sailed at Wigram 49 days with 45 Sundays and 4 none Sundays

13 to 26 members sail each Sunday with the year's average being 17

The total fees paid to the museum was \$9,680.00

The club karts have been hired out to 83 individuals generating \$1,660.00 income.

Since taking over tyre sales the club has generated \$1,420.19 profit.

Also my appreciation and thanks goes to the many other unsung hero's who help make the club tick. That's people who:


- set up the track

**Business:**

**Hard surface track extensions, funding & track options;**

B Emms updated the meeting with progress to date; Fulton Hogan has been approached formally with a submission seeking their support to complete our project. Several possible means of raising additional funds were outlined as were investigations on other methods of building hard surface track. Discussion took place on options for raising additional funds should that prove to be necessary.

**Club development fee;**

P Kingsbury outlined a proposal to raise club funds by applying a levy to members racing at Wigram on Sundays and put the following motion to the meeting.
